The Institute has a turnover of c. £3m, 21 staff (excluding a further 60 contracted examiners and tutors), 3,300 members and around 4,000 exam candidates per year 90 countries.



Membership of the IBD incorporates seven Sections of organised groups of members based upon geographical areas.

We have invested heavily in technology and have successfully established a fully online model for our courses. Section 9: Specific Job Description

Honorary Officer Job Description: (Deputy President, President, Immediate Past President.

The post holder should:

- Be a high-profile, inspirational leader with an international reputation, and drawn from the global membership of the IBD.
- Agree to serve for a period of six, or by exception five, years, elected annually at the AGM, with two years as deputypresident, one (by exception)/two years as president, (then two years as past president).
- Be drawn, alternately wherever possible, from the UK and 'overseas' sections, being selected on a periodic basis, where possible, from each major wings of the profession, namely scientific research, brewing, distilling and equipment/material supply organisations.
- Drive the IBD with courage, conviction, influencing skills and demonstrate a strong, yet inclusive, leadership style.

- Attend, and chair when President, the Board of Trustees and Council meetings, together with other meetings (via Video Conference or Face to Face, as required) called throughout the year.
- Represent the IBD in an ambassadorial role either through correspondence, in person or in an online capacity.
- Give sufficient time to the IBD to discharge their responsibilities effectively: this includes Council (3 a year) and Trustee meetings (4 a year), training days, preparation for meetings, and sitting on /or chairing Board Committees.
- The CEO and Chair of the Board of Examiners are responsible to the Board and report into the President which involves an additional time commitment.



Section 10: Terms of Appointment

- All applicants will need to be current members of the Institute of Brewing & Distilling.
- IBD Members can nominate potential Trustees who will require endorsement by two current members of the IBD.
- Each IBD Section may propose candidates for election to the role of Trustee.

The Nominations Committee will consider the candidates being received from Sections or Members.

In the event of insufficient candidates being received from Sections or Members, the Nominations Committee will conduct a search and identify suitable candidates.

Following formal election by the Membership at the Annual General Meeting in September the trustees will be expected to:

- To serve for, up to a maximum of six years.
- Travel to Head Office in London or other locations, as needed – generally once per year.
- Have sufficient time to give to the IBD to discharge their responsibilities effectively: this includes Trustee meetings (4 meetings/year), preparation for meetings, training days, sitting on /or chairing Board Sub-Committees, a total of at least 12 days per annum.
